Welcome to Dei Amor Photography. By accessing this website or booking photography services, you agree to the following Terms & Conditions.

1. Services

Dei Amor Photography provides photography services including, but not limited to:

- Family photography
- Portrait photography
- Couples' photography
- Lifestyle photography
- Event photography
- Digital image delivery
- Photo organisation and scanning services

All services are subject to availability and confirmation.

2. Bookings and Payments

A booking is considered confirmed once:

- the required deposit has been received (if applicable), and
- confirmation has been provided by Dei Amor Photography.

Final payment terms will be outlined prior to the photography session.

Failure to complete payment may result in cancellation of services or withholding of image delivery.

3. Cancellations and Rescheduling

If a client needs to cancel or reschedule a session, reasonable notice is appreciated.

Dei Amor Photography reserves the right to reschedule sessions due to:

- unsafe weather conditions,
- illness,
- emergencies, or
- circumstances beyond reasonable control.

Deposits may be non-refundable where stated at the time of booking, however reasonable efforts will always be made to accommodate rescheduling. Where the client does not show up to a session, deposits will be non-refundable.

4. Copyright and Image Ownership

All photographs remain the intellectual property and copyright of Dei Amor Photography unless otherwise agreed in writing.

Clients receive personal-use rights for delivered images.

Images **may not** be:

- sold,
- commercially reproduced,
- heavily altered,
- filtered,
- edited, or
- submitted to competitions.

without prior written permission.

5. RAW Files and Editing

RAW/unedited image files are not included and will not be supplied to clients.

Delivered images are professionally edited in the artistic style of Dei Amor Photography.

Further editing, excessive filtering, or alteration of delivered images is discouraged as it may misrepresent the photographer's work.

6. Turnaround Times

Estimated editing and delivery timeframes will be communicated at the time of booking.

Delivery times may vary during peak periods.

7. File Retention

Edited image galleries and files are retained by Dei Amor Photography for approximately twelve (12) months following delivery. Files are kept on an external hard drive and will be protected as per Dei Amor Photography's Privacy Policy.

Clients are responsible for downloading and backing up their photographs after delivery.

Dei Amor Photography cannot guarantee indefinite storage of files.

8. Client Responsibility

Clients are responsible for:

- arriving on time,
 - ensuring children are supervised during sessions,
 - obtaining permission for photography locations where required,
 - advising of any important medical, accessibility, or safety considerations.
